# **MARKETING (legitimate interest)**

### 1. Purpose of personal data processing:

#### 2. Legality of personal data processing:

The controller processes personal data until the data subject raises an objection to sending commercial offers or for the maximum period of 5 years since the last business activity with the data subject.

#### 7. Legitimate interests of the controller:

Legitimate interest of the controller is processing of personal data of customers (in the necessary extent) for the purpose of sending commercial offers to customers, the purpose of which is (for example) to inform customers about new goods and services of the controller in order to promote their marketability.

#### 8. Transfer of personal data of data subjects to third countries:

Personal data are not being transferred to a third country.

#### 9. Technical and organizational security measures:

Organizational and technical measures for the protection of personal data are processed in the internal regulations of the controller. Security measures are implemented in the areas of physical and object security, information security, cipher information protection, personal,



administrative security and sensitive information protection, with precisely defined competences and responsibilities set out in the security policy.
